COVID-19 created swift and quick changes to primary elections held during and after March 2020, and with the speed of those decisions due to health and safety of the voting population, threats and vulnerabilities to the process may not have been widely considered. Table 1 identifies the voting methods, by state, for the 2020 U.S. Primary Elections and whether the approach constitutes a change from its previous voting methods in primary elections (NCSL, 2020; Gardner, et al., 2020; Giles & Staff, 2020; Ballotpedia, 2020; Corasaniti & Saul, 2020). Of note, over 40% of all states modified their voting methods since their last primary election (i.e., 2018 or 2019) to include mail voting in some form.

The effects of the pandemic continued for the 2020 General Election. Table 2 identifies the voting methods by state and for the District of Columbia (Kavanagh, et al., 2020; Scanlan, 2020; HowToVote, 2020). Note that 48 of 51 states and D.C. expanded their traditional use of

mail-based voting (94%). Only five states (Indiana, Louisiana, Mississippi, Tennessee, and Texas) did not allow COVID-19 as an excuse to vote by mail (Rabinowitz & Mayes, 2020).
